The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hours on 26<sup>th</sup> November 2024 at the office of Road Infrastructure Development Office, Dang. Bids must be valid for a period of 90 days (i.e. up to 24<sup>th</sup> February 2025) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of above mentioned, which shall be valid up to 26<sup>th</sup> March 2025.
