5. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before **12:00 Hours** on **22 March, 2024**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 Hours** on **22 March, 2024** at the office of **Road Infrastructure Development office, Dang**. Bids must be valid for a period of 90 days, (**20 June, 2024**) after bid opening and must be accompanied by the scanned copy of the bid security in .pdf format, amounting to a minimum of following mentioned below, which shall be valid for 30 days beyond the validity period of the bid (**i.e. 20, July 2024**)
7. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
