Bidders submitting their bid electronically should deposit *NRs. 3000.00* for the cost of Bidding Document in the Project's Revenue (Rajaswa) Account as specified below and the scanned copy (PDF Format) of the bank deposit voucher shall be uploaded by the Bidder at the time of electronic submission of the bids. - 4. Pre-bid meeting shall be held at *Road Infrastructure Development office*, *Dang* at 13:00 Hours. on 10 April, 2025
- 5. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egpon or before 12:00 Hours on 20 April, 2025. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hours on 20 April, 2025 at the office of Road Infrastructure Development office, Dang. Bids must be valid for a period of 90 days, (19 July, 2025) after bid opening and must be accompanied by the scanned copy of the bid security in .pdf format, amounting to a minimum of following mentioned below, which shall be valid for 30 days beyond the validity period of the bid (i.e. 18 August, 2025)
- 7. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
