2. *Road Infrastructure Development Office Dang* invites electronic bids from eligible bidders for the construction of *projects mentioned below* under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

6. Electronic bids must be submitted to the office through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 Hours** on **23<sup>rd</sup> January 2024**. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 Hours** on **23<sup>rd</sup> January 2024** at the office of **Road Infrastructure Development Office, Dang**. Bids must be valid for a period of **90 days (i.e. up to 22<sup>nd</sup> April 2024)** for the **Contract ID: RIDO/DANG/NCB/W/78/080/081** and **120 days (i.e. up to 22<sup>nd</sup> May 2024)** for the **Contract ID: RIDO/DANG/NCB/W/79/080/081** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of above mentioned, which shall be valid up to **22<sup>nd</sup> May 2024** for the **Contract ID: RIDO/DANG/NCB/W/78/080/081** and **21<sup>st</sup> June 2024** for the **Contract ID: RIDO/DANG/NCB/W/79/080/081**
8. If the last date of purchasing and /or submission falls on a government holiday, the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
